Sub : Policy regarding allotment of sites for booths for distribution of milk at various Nodes of New Bombay.

## AGENDA NOTE :

CIDCO has been in correspondence with Dairy Development Department, Warana Sahakari Dudh Utpadak Prakriya Sangh Ltd. and Maharashtra Rajya Sahakari Dudh Maharangh Maryadit for star ing Milk distribution centres at various nodes of New Bombay.

- 2. As regards the present milk distribution network in New Bombay, the Dairy Development Department asks the Co-operative Societies and individual distributors to lift Wilk from Kurla dairy and make their own distribution arrangement. However, the other two organisations viz, Warana Sahakari Dukh Utpadak Prakriya Sangh Ltd., and Maharajya Sahakari Dukh Mahasangh Maryadit have started their own distribution network in New Bombay. But these distribut are scattered haphazardly.
- The above organisations have requested for allotment of sites in various sectors of our developed nodes for distribution of milk and milk products. The norm is one site of booth for distribution of 300 litres of milk. As per these norms one sector will require about 3 milk booths. The area required for a milk booth is around 3.5 to 5.0 M<sup>2</sup> plus place for movement of people. It is understood that the RIC is charging Rs. 50/- per month per milk booth as ground rent and verying amount of License for which CIDCO is not in a position to charge. It is therefore proposed to charge Rs. 50/- per month per milk booth as ground rent.
- 4. It is proposed to devise a policy to allot sites Reserved for milk booths to the following organisations in various sectors of each node being developed by CIDCO.
  - . Dairy Development Department.
  - 2. Warana Sahekari Duch Utpedak Prakriya Sengh Ltd.
  - 3. Mahireshtra Rajya Sahekari 2 a hasangh Maryadit.
  - 4. Social Johnson's Co-operative Sociates and/Co-operative Sociaties and
  - 5. Other Somi-Government and Government milk distribution aguncies.

5. "The Board is requested to consider the Agenda Item and to pass ... Resolution in terms of the following draft Resolution with or without modifications".
