1. CIDCO had pre-qualified your agency for the purpose of DGPS survey & submission of plot coordinates for obtaining NOC from AAI for Navi Mumbai International Airport under NOCAS upto three years from 18th December, 2019 i.e. upto 17th Dec. 2022. It is now proposed to extend the empanelment for further three years i.e. upto 17th Dec. 2025. Therefore, you are requested to submit the following documents for further processing:


1. List of DGPS equipment with manufacture & make/model details.
2. Accuracy of DGPS Equipment
3. List of works related to experience in DGPS Site Survey Works in last 5 years (with details of client, name of work, cost, duration and brief nature of work)
4. Skilled Manpower list with qualification & experience for DGPS Surveys
5. Proof of Ownership/Invoice of DGPS Equipment
6. List and locations of clients served for last 3 years for Airport NOCs

All the above self-certified documents are to be submitted to the office of the undersigned within Ten Days i.e. upto 5th Dec. 2022.

2. The Applicant who wish to extend prequalification for further three years, will be asked to carry out Survey of Site Coordinates i.e. LAT/LONG in WGS84 format for locations specified in presence of CIDCO's representatives (Mr. Santosh Khusnure and Mr. Devendra Mokal, Transportation Engineers) for authentication of DGPS instrument.
3. All the terms and conditions specified from time to time by CIDCO will be binding on the agency and CIDCO has sole discretion regarding decision of pre-qualification.
4. This prequalification/empanelment procedure is continuous and if any new applicant wishes to submit above documents in next three years, the same can be submitted to the office of CGM (T&A), Transportation & Communication Dept., 6th Floor, CIDCO Bhavan, CBD Belapur, Navi Mumbai-400614 in the month of December every year. Evaluation of such applications shall be considered once in every year. Standing Notice shall be available on CIDCO website.
