- Pre-Qualification of Surveyors with DGPS for the purpose of issue of NOC from AAI

1. CIDCO pre-qualified Seven the agencies for the purpose of survey & submission of plot coordinates for obtaining NOC from AAI for Navi Mumbai Airport under NOCAS upto three years upto 17<sup>th</sup> Dec. 2025.
2. It is now proposed to extend empanelment for the further three years i.e. upto 17<sup>th</sup> Dec. 2028. Therefore, you are requested to submit following documents:
  - a) List of Differential Global Positioning System (DGPS) equipment's with manufacture & make/model details.
  - b) Accuracy of DGPS Equipment/calibration certificate.
  - c) List of works related to experience in DGPS Site Survey Works in last 5 years (with details of client, name of work, cost, duration and brief nature of work)
  - d) Skilled Surveyors list (minimum two) and photo with qualification certificates (Diploma in Civil Engg /BE Civil) & minimum three (03) years' experience for DGPS Surveys.
  - e) Proof of Ownership/Invoice of DGPS Equipment
  - f) List and locations of clients served for last 3 years for Airport NOCs with contact numbers for verification.
  - g) The Surveyors having License with similar experience in municipal authorities will be preferred.

All above self-certified documents are to be submitted to the office of the undersigned within Ten Days i.e. upto 25<sup>th</sup> Nov. 2025.



3. The Applicant who wish to extend prequalification for further three years, will be asked to Survey Site Coordinates i.e. LAT/LON in WGS84 format for locations specified in presence of CIDCOs representative (Mr. Devendra Mokal, Transportation Engineer) for authentication of DGPS instrument.
4. All the terms and conditions specified from time to time by the CIDCO will be binding on the agency and CIDCO has sole discretion regarding decision of pre-qualification and these surveyors are prequalified only for issuing certificates for obtaining AAI airport NOCs

This prequalification/empanelment procedure is continuous and if any new applicant wish to submit above documents in next three years, the same can be submitted to the office of CGM (T&A), Transportation & Communication Dept., 6<sup>th</sup> Floor, CIDCO Bhavan, CBD Belapur, Navi Mumbai-400614 in the month of December every year. Evaluation of such applications shall be considered once in every year. Standing Notice shall be available on CIDCO website.
