## RESULTS OF THE PERSONAL INTERVIEW CONDUCTED ON 17.09.2016 AT CIDCO BHAVAN, CBD BELAPUR FOR THE POST OF DEVELOPMENT OFFICER (GENERAL)

Merit list is drawn on the basis of the marks obtained in the online exam and the personal interview and the final merit list is out of 220 marks (200 marks online exam and 20 marks personal interview).

If two or more number of candidates has acquired same number of marks, then for deciding their selection or their place in selection list or waiting list if any, the committee decided to follow the guidelines given in शासन निर्णय क्रमांक प्रानिमं-1215/(प्र.क्र.५५/१५)/१३-अ, दिनांक ५ ऑक्टोबर २०१५. Thus the final merit list was prepared, based on marks obtained by the candidate in the online exam and the marks given during interview and having consideration for social & horizontal reservation policies of the Government of Maharashtra & different directives available on this issue. The selection committee unanimously decided to consider 1:1 ratio per post advertised while preparing the waiting list since some candidates were selected for the post of Asst. Development Officer (Gen) as well and there was a possibility that the waiting list might be exhausted resulting in the posts remaining vacant.
