शहर व औद्योगिक विकास महामंडळ, मर्यादित (सिडको) नैना यांनी विशेष नियोजन प्राधिकरण म्हणून तयार केलेल्या व महाराष्ट्र प्रादेशिक नियोजन व नगर रचना अधिनियम, 1966 च्या कलम 68 (2) प्रमाणे मंजूर केलेल्या प्रारूप नगर रचना परियोजना, नैना क्र. 7 (उसर्ली खुर्द (भा), कोळखे (भा), देवद (भा), विचुंबे (भा), शिवकर (भा)) चे लवादीय कामकाज कलम 72 (4) प्रमाणे सुरु आहे. या संदर्भात महाराष्ट्र नगर रचना नियम 1974 च्या नियम क्र. 13(3) प्रमाणे विहित नमुना 4 मध्ये विशेष सूचना परियोजनेतील प्रत्येक भूखंड धारकाला पाठविलेली आहे. परंतु अपुरे पत्ते किंवा अन्य कारणामुळे उक्त विशेष सूचना काही भूखंड धारकांना मिळण्यामध्ये अडचण होऊ शकते.
