- 5. Profit and loss statement and assets and liability statements for last three assessment years (2017-18, 2016-17, 2015-16) duly certified by the Chartered Accountant.
- 6. Self-attested copy of the ITR-for the assessment year 2017-18.
- 7. Attested copy of Income tax Permanent account Number.
- 8. Attested copy of Goods and Service Tax certificate (GST) or documentary proof of GST number.
- 9. Attested copy of the proof of address.
- 10. The firm/ agency shall submit an affidavit on Rs 300/- court fee stamp that their firm/ agency has not been declared as bankrupt by any institution or Govt/ Authority /Department., firm/ agency is not blacklisted by Govt., firm/ agency has not been adjudged by any court as insolvent, not convicted under any law for an offense involving moral turpitude or any criminal activities etc.

- 13. In case of partnership firm, notarized certified copy of registered or notarized partnership deed shall be submitted along with the tender.
- 14. In case of partnership firm, notarized Power of Attorney of authorized person shall also be submitted.
- 15. The applicant should also produce original documents for verification if called for. Failure to attach requisite documents with application will render applicant not eligible for qualification of bid without any intimation.

- 1. The Pre-qualification On-Line submission shall be accompanied all the above mentioned documents.
- 2. The applicant should also produce original documents for verification if called for. Failure to attach necessary documents with application will render applicant ineligible for bidding without any intimation.
- 3. Tender documents shall neither be sent nor received by Post/Courier.
- 4. Right to issue/download tender documents is reserved with CIDCO. CIDCO reserves right to reject any or all tenders without assigning any reason and the same shall be at the entire discretion of CIDCO. CIDCO's decision in this respect shall be final and binding.
- 5. Conditional tenders shall be summarily rejected.
- 6. The offer shall remain valid for a period of One Hundred Twenty (120) days from the date of submission of tender.

Before submitting the offer the tenderer shall inspect the proposed site of work and acquaint themselves with the site, local conditions, means of access to site, nature of work and all matters pertaining there to at his own expense and carryout the financial feasibility of Operation of Pay & Park system at Vashi Railway Station and accordingly quote the financial offer. No complaint whatsoever about the site or conditions and parking nature thereof of the Pay & Park area will be entertained after the offer is submitted to the Corporation.
