This empanelment procedure is continuous and if any new applicant wish to submit above documents in next five years, the same can be submitted to the office of Sr. Transportation Engineer (S&A), CIDCO, Transportation & Communication Planning Dept., 6th Floor, CIDCO Bhavan, CBD Belapur, Navi Mumbai-400614 before 31st December every year. Evaluation of such applications shall be considered once in every year. Standing expression of Interest shall be available on CIDCO website.
- 3. It is the duty of the empanelled consultants to maintain the validity of their MoEF/ NABET/ NABL accreditation at all times during the empanelment, failing which they will not be eligible to submit their financial quotes.
