- A) Subject: Revised Policy for allotment of plots for Religious and Spiritual purposes Approval received from Govt. vide letter No. CID-1814/Pk-24/UD-10 dated 9/9/2014.
- B) Issue for consideration: Appraisal note to Board regarding approval received from Govt. with directives / modifications to the revised policy for allotment of plots for religious and spiritual purposes approved by Board vide B.R.no.10980 dated 4-2-2014.
- C) Nature of approval: Administrative approval
- D) Details about the proposal:
 - 1. The Board vide resolution No. 10980 dated 4-2-2014 has approved the revised policy guidelines for allotment of land for religious and spiritual purpose. The Board has further resolved that the resolution be taken up for implementation immediately and also sent to Urban Development Deptt., GOM for advise, if any. In case objection is received from Urban Development Deptt., GOM, policy be re-submitted to the Board with the objection. On approval of Board the policy was submitted to Govt. vide letter dated 17-4-2014. The revised policy was also submitted to Principal Secretary, UDD vide letter dated 16-6-2014 under the signature of VC&MD for perusal and approval of Govt.
 - 2. The Govt. vide letter No. CID-1814/P.K.24/UD-10 dated 9th September, 2014, annexed at <u>Annexure-A</u> has approved the revised policy for allotment of land for religious and spiritual purpose approved by Board vide BR No. 10980 dated 4-2-2014 with some directives / modifications to the policy. The directives / recommendations suggested by Govt. in the policy are given below:-

Necessary corrections in the Annexure indicating list of documents to be submitted shall be made.
3	The Govt. has further observed that in the category of State, National and International religious Trust as per eligibility criteria the Trust should have completed period of 4 years from the date of registration whereas in the same category for the spiritual Trust in the eligibility criteria it has been indicated that the Trust should have completed a period of 10 years from the date of registration. The Govt. has stated that the reason for keeping the difference in years of experience in spiritual and religious trust is not clear and it would be appropriate if for the both the categories i.e. for Spiritual and Religious Trusts at State, National and International level, the Trust should complete a period of 10 years from the date of registration.	As recommended by Govt. in the category of State, National and International religious Trusts, it is proposed to make the change in the eligibility criteria that the Trust should have completed 10 years from the date of registration.
4	The Govt. has further directed that in the category of Spiritual trust functioning at State, National International level eg. Vipassanna in such cases the condition of maximum plot of 2000 m2 may not be sufficient and hence while considering such uses in the category of spiritual purposes in exceptional cases, it would be appropriate if more than 2000 m2 area is considered with the approval of Govt. and such provision may be made in the existing policy. 
After discussions, the Board unanimously passed the following Resolution:

Policy as per B.R.No. 11229 dtd. 2-12-2014 as per changes made by Govt. vide letter No. CID-1814/PK-24/UD-10 dated 9/9/2014 to B.R.No.10980 dated 4-2-2014, the policy for allotment of plots earmarked for religious and spiritual uses in Navi Mumbai:-

1. I) Need for revised Religious / Spiritual Policy:-

- (i) To bring transparency:
 - To make the allotment process transparent.
 - To adopt web based method of receiving applications.
- (ii) To categorize spiritual and religious Trust and relaxation of eligibility norms for the trust formed by residents of Navi Mumbai and PAPs:
 - To have a policy where by there is scope for local Trusts as well as national / international level trusts to set up their religious and spiritual centers.
 - For national / international religious trusts eligibility criteria is revised to registration under any Charitable Trust act in India.

II) Categories proposed in Religious and Spiritual Trusts

A. Religious Trusts:

a) Local Trust (inserted as per GOM's letter dated 9/9/14)

Trusts formed by residents of Navi Mumbai / PAPs and are willing to take up plot for religious purpose.

b) State / National / International Trust

Trust registered under any charitable Act in India having existence at State / National / International level.

B) Spiritual Trusts:

a) Local Trust

Local branches of Spiritual Trust formed by residents of Navi Mumbai and registered under BPT Act, 1950.

b) State / National / International Trust

Spiritual Trust registered any charitable Trust Act in India having existence at National / International level.

 - 10% of vacant plots to be reserved for future needs
- 2. 3 to 4 plots of 2000 sq.m shall be earmarked for spiritual and religious trusts having State / National / international existence
- 3. Plots in the range of 300 to 500 sq.m. or more as identified by planning department to be earmarked for Local Religious and Local branches of Spiritual Trust
- Plots in the range of 1000 to 2000 sq.m. to be allotted for minor religion 4. at least one in each node subject to availability of plots
- 5. If religious trust of a minority trust already has land less than 2000 sq.m.. then trust is entitled for additional plot to equate the additional plot size. In order to meet the need of increased population. However this will include all sub-sects of that minority religion.
- 6. Meditation centres to be constructed by CIDCO in South Node, which shall be open for meditation purpose
- Unauthorised religious structures shall be dealt case by case as per 7. Govt. GR No. CTM - 0909/PK/557/Part 2 VS-IB Dated 5th May, 2011

- Supported by maximum no. of families from the node where the plot is advertised.
- Applicant Trust should have maximum years of experience
 - a) if more than 75 % of the trustees are from the same sector.
 - b) if more than 75 % of the trustees are from same node.

(B) Spiritual Trusts -

- Applicant trust having no. of centres at State/ National / International level.
- Supported by maximum number of families from Navi Mumbai.
- Methodology /required documents for process:-3.
- Methodology: For Local Religious Trust / Branches of Spiritual Trust and A. State / National level Religious / Spiritual Trust and Minor Religious Trust
 - Invitation of application through announcement of vacant religious / spiritual plots for major and minor religion / Local Religious and Spiritual Trust / National / International Religious and Spiritual Trust separately.
 - b) Announcement will be valid for three months



- c) Acceptance of application in specific time limit
- d) Processing of application within stipulated time limit
