

ORDER

Maharashtra
Cooperative
Societies
Act, 1960.

No. CSL-1094/2874/CR-106/15-C.- In exercise of the powers conferred by Section 3 of the Maharashtra Cooperative Societies Act, 1960 (Mah XXIV of 1961), the Government of Maharashtra hereby-

- (i) appoints the Joint Registrar of Cooperative Societies, City and Industrial Development Corporation of Maharashtra Ltd., to assist the Registrar; and
- (ii) confers on him the powers of the Registrar under the Maharashtra Cooperative Societies Act, 1960 (Mah. XXIV of 1961), and the Maharashtra Cooperative Societies Rules, 1961, specified against him in respect of the cooperative Housing/Premises Societies of the allottees of the City and Industrial Development Corporation of Maharashtra Ltd., falling in Thane and Raigad Districts.


