Subject : Empanelment of Consultants for Various Departments of CIDCO

Board has accorded an approval to the Empanelment of Consultants for various Departments of CIDCO for required support for various projects vide Board Resolution No. 11360 dated 19.05.2015.

I) HIGHLIGHTS :

1. The empanelled consultants list is valid for the projects costing up to Rs. 150 Crores and consultancy fee up to Rs. 5 Crores.
2. Financial quotes [Request for Quotations (RFQ)] from the empanelled consultant on work to work basis need to be invited by respective departments through on-line limited e-bids for the projects costing up to Rs. 150 Crores subject to anticipated consultancy fee up to Rs. 5 Crores. Open e-bids will be invited for the projects costing more than Rs.150.00 Cr. or anticipated consultancy fee is more than Rs. 5.00 Crores..
3. Financial quotes from the empanelled consultants can be invited by the respective departments as per the requirement
4. Class & Limit of empanelled consultants :

5. Consultants on Class A1 can also be used for the consultancy services of projects mentioned under Class A2 to Class C, similarly Class A2 consultants can be used for Class B&C, and Class B consultants can be used for Class C.
6. The bidding programme shall be completed within 10 days for the limited e-bids.
7. If minimum two RFQ are not received or if there are no empanelled consultants for a particular field, then open e-bids shall be invited for such particular consultancy assignment.
8. In addition to e-mail intimation through on-line process, RFQ shall be displayed on website.

II) VALIDITY OF PRESENT EMPANELMENT

1. This empanelled consultants list shall be valid for one year i.e up to 09.06.2016 or till new E.O.I invited for empanelment for entire categories whichever is later.
2. As the empanelment is a continuous process and need to be updated periodically by the concerned departments through the same terms and norms and marking system for using the present E.O.I. bid documents.
3. **All earlier empanelled consultants shall be no more valid & this list will supersedes all earlier empanelled list.**


IV) ADOPTION OF DIRECT EMPANELMENT:

(D) **Details about the Proposal:**

i) It is necessary to empanel consultant to have access to appropriate advisory support for various construction projects such as Housing, Infrastructure works, Railway Network, Metro, Water and Sewerage Treatment Plant, Telecommunication, Iconic Project like, NRI type housing, Railway Station, Golf Course, Central Park, Exhibition Centre etc.

ii) **NEED FOR EMPANELMENT OF CONSULTANTS:**

Every organization with time tends to stagnate in respect of knowledge and skills of its employees. The need to re-invent itself is then forced upon it by the plethora of advancement and the inventions in the field in which the organization is active. As per the Board directives empanelment of consultants was done and list circulated on 24.02.2014 for one year validity that is expired on 23.02.2015.

Bidding & Scrutiny Process of Expression of Interest (EOI):

Expression Of Interest (EOI) for empanelment of additional expert consultants were invited by publishing the notice in leading News Papers on 28.08.2014. The date of sale of booklet was 28.08.2014 to 15.11.2014 & receipt of booklet on 28.11.2014. EOI was also displayed on website.

The total 642 no. of applications for 58 categories of 20 Departments were received from 139 No. of Consultants. (Annexure - II). Detailed statement tabulated is as under:

Respective departments scrutinized the applications and submitted to this office, based on scrutiny reports a meeting was held under Chairperson of CVO on 12.02.2015 and subsequent discussions held with External Experts, it was decided to further categorize these consultants in three classes as Class A-Unlimited, Class B- Up to 50 Crs. & Class C- Up to 15 Crs. as tabled below. External Experts also agreed for these bifurcation norms.

Selection Process for empanelled consultants:

Presentation was given to VC&MD on 17/04/2015 at 2nd floor, conference room, CIDCO Bhavan regarding scrutiny norms and proposed bidding process. During the presentation, the following norms were finalized for inviting limited e-bids from the empanelled consultants.

- i). As and when required CIDCO will invite financial quotes [Request for Quotations(RFQ)] from the empanelled consultant on work to work basis by respective departments through on-line limited e-bids for the project costing up to Rs. 150 crores subject to consultancy fee up to Rs. 5 crores. Open e-bids will be invited for the projects costing more than Rs.150.00 Cr. Or if anticipated consultant fee is more than Rs.5.00 Crores..
- ii). By empanelling, Request For Quotation (RFQ) is made available to all departments, hence Financial quotes from the empanelled consultants can be invited by the respective departments as per the requirement
- iii) Bifurcated for all categories as under except for categories mentioned in para iv) below:

- v) Consultants on Class A1 can also be used for the consultancy services of projects mentioned under Class A2 to Class C, similarly Class A2 consultants can be used for Class B&C, and Class B consultants can be used for Class C.
- vi) The bidding programme shall be completed within 10 days for the limited e- bids.
- vii) If minimum two financial quotes are not received or if there are no empanelled consultants for particular field, then open e-bids shall be invited for such particular field consultancy assignment.
- viii) In addition to e-mail intimation through on-line process, RFQ shall be displayed on website

Validity of present empanelment and future course of action:-

Although the EOI is invited for one year period, the proposed empanelled consultants list shall be valid till new E.O.I invited for empanelment for entire categories i.e for total of 2 years. New EOI will be invited before 8 months from the date of expiry of proposed empanelment list with validity period of minimum 3 years.

The empanelment is a continuous process and need to be updated periodically by the concerned departments based on the same terms and norms and marking system by using the present E.O.I. bid documents.



Scrutiny Committee for future course of action:

A committee consisting of CE(NM) as a Chairman, along with other HOD,s to be formed to scrutinize disqualified agencies grievances and re-scrutiny of such agencies. The direct applications of consultants received even after EO bidding process can also be scrutinized by the committee and recommend the same for approval of VC&MD for inclusion in empanelled list from time to time. Committee is also authorized to recommend de-listing of non-performing consultants from the empanelled list periodically to VC&MD.
